Dear Mr. Livas:

The year 2011 will be remembered as a year of great accomplishments and extreme challenges for the Downey Police Department. As we strive to improve all aspects of our operation, we understand that we must do so with fewer resources and funding; however, the safety of our community is our primary mission. We will not let obstacles deter us from protecting those who live and work in Downey.

The Governor's Parole Realignment has left municipal and county agencies responsible for released prisoners who were previously supervised by the California Department of Corrections Parole. The majority of these offenders are now under the direct supervision of local law enforcement, without the benefit of additional funding; this has placed a significant burden on resources. To meet the challenges during these drastic changes in the justice system, we are participating in a Southeast Regional Task Force, a collaborative effort with other police departments to conduct compliance checks on recently released inmates and ensure adherence to parole/probation conditions. The ultimate goal is to reduce the rate of recidivism and keep the public safe.

This year the Downey Police Department identified an uptick in property-related crimes, which negatively impacted our community. To address the increase, we implemented the "Crime Impact Team," a group of handpicked officers who utilize their unique talents and experience to focus on crime and quality of life issues. Their presence has resulted in a positive effect on crime. Our long-term goal is to sustain these reductions and use creative measures to fight crime through both traditional and non-traditional policing methods.

On September 22, 2011, the Department held an unveiling of our Fallen Officer Memorial, honoring Officer Wayne Presley. This emotional and beautiful piece of art commemorates the 30-year anniversary of Officer Presley's death at the hands of a drunk driver. Attending the ceremony were Officer Presley's widow, Linda, family members from the State of Missouri, as well as Wayne's partner retired Sergeant Steve Guthrie, who was critically injured that terrible night. The event, planned by the members of our staff, was awe-inspiring and memorable. This was the proudest moment of my police career.

In furtherance of the true law enforcement mission, "to protect and to serve," this Department is dedicated to continue to apply the highest level of professional service to all who live, work, and play in the City of Downey.

On behalf of the Men and Women of the Downey Police Department, I wish to express our sincere appreciation to you and the City Council for your continued support.

## YEAR IN REVIEW

Early in the year, the **Special Enforcement Team** (S.E.T.) seized four electronic slot machines from two Downey businesses which were being used for **gambling** purposes.

In June, the Special

Enforcement Team
conducted a series of
alcohol compliance checks
at local bars and liquor
stores resulting in arrests
for selling alcohol to a
minor, for selling narcotics,
and for an establishment
providing alcohol after hours.
Later that month, follow-up

inspections resulted in an additional arrest for selling alcohol to a minor and a report of an establishment who had liquor bottles contaminated with insects.

In total, the SET team conducted 32 alcohol compliance checks at bars and liquor stores and 18 City park checks during 2011.

In January the Downey Code Enforcement Unit's continuing efforts against illegally posting signs on the public right-of-way resulted in a misdemeanor conviction of a habitual violator of City public nuisance laws. The violator was placed on 36 months summary probation, ordered to perform six days of CalTrans service and pay \$100 to the State Victim's Restitution Fund and \$6,800 to the City.

Through their diligent efforts, the *Code Enforcement Unit* ensured that a bank-owned, vacant property in the 12800 block of Downey Avenue was cleaned up. The property, which had been vandalized and occupied by squatters, is now well maintained.

In April and October, DPD personnel, Explorers and the Drug Enforcement Administration sponsored the *Prescription Medication* "Take Back" at the Discovery Sports Complex. These events offer community members a safe and convenient opportunity to rid their homes of potentially dangerous drugs and minimize the potential for misuse and abuse. The two days resulted in 773 pounds of drugs turned in along with a large number of used hypodermic syringes.





In April, Neighborhood Watch, together with Keep Downey Beautiful, hosted a Clean-up event at Crawford Park. Illegal park activities prompted residents to organize the event, which included shrubbery removal and trimming overgrown bushes creating better visibility. This great volunteer turnout of neighbors, a local church group, and Council Member Brossmer demonstrated the group's willingness to donate a little time and make a big difference in their community.

Neighborhood Watch held a meeting on Elm Vista Drive in June, with approximately 20 residents attending. Police and Code Enforcement officers provided crime prevention tips and addressed citizen concerns. Council Members Gafin and Guerra were in attendance.



The *Donovan Neighborhood Watch* group held its Annual Summer Barbecue in August. The Downey Police and Fire Departments provided some helpful tips on bicycle and fire safety. Council Members Gafin and Guerra joined the group in this wonderful community event.



Later in August, the *Dunrobin*Avenue Neighborhood Watch
group hosted its 3rd Annual Barbecue.
This group was established in 2008
and remains very active. Residents
had the opportunity to meet Council
members as well as members of the
Police and Fire Departments.

Downey PD is pleased to report that on December 15th, the 100th Neighborhood Watch group in the City was established at the Imperial Village Apartments.

## YEAR IN REVIEW

In March, the *Downey Emergency Preparedness Committee*, with assistance from CERT (Community Emergency Response Team) volunteers, Downey Police and Fire Explorers, and the Warren Red Cross Club, distributed 4,000 free plastic emergency water storage barrels to community members, all donated by the Downey Coca Cola facility.

Also in March, volunteers from the Police and Fire Departments, CERT, the *Emergency Preparedness Committee*, Warren High Red Cross Club and the Rio Hondo Chapter of the Red Cross, raised over \$25,000 for the American Red Cross to help the people of Japan recover from their earthquake and tsunami. Volunteers solicited donations from motorists at all the entrances to Stonewood Shopping Center.

captains were educated on how
to prepare their neighborhoods
for a disaster.



Downey PD's Special Response Team (S.R.T.) participated in a multi-agency training this past March, hosted by the Pasadena Police Department and the L.A. County Sheriff's Department. The training was geared toward handling unruly crowds and acts of civil disobedience as well as

providing evacuation plans during a natural disaster. Over 300 law enforcement officers from numerous cities and agencies attended.

The S.R.T. (Special Response Team) received training in August to prepare officers for response to wild fires, where officers would assist with emergency evacuations or area security.





In June, Downey PD, with assistance from South Gate PD, sponsored our first *Defensive Driver's Awareness Program* for police employees. The training included classroom lecture, as well as obstacle courses (located at the Downey Studios) designed to challenge driving skills.

In September, the Range Staff joined with the Use of Force Staff to provide "Simmunitions" training.

Simmunitions consists of using duty weapons that are modified to only fire paint projectiles. Using this equipment enables officers to safely train in a variety of scenarios that closely match what they may encounter when responding to actual calls. The equipment also allows the officers to see firsthand the value of maintaining their critical skills and using good judgment during stressful encounters.





In the months of September and October the Downey Police Department *Defensive Tactics Unit* conducted perishable defensive skills training to all sworn staff. The training consisted of an 8-hour day for all sworn personnel. The class covered case law concerning use of force issues, handcuffing, searching, impact weapon defense, personal weapon defense and ground defense. At the conclusion of the class, all students participated in and completed a practical critical scenario.


## YEAR IN REVIEW

Five *Peer Support Team* members attended a Critical Incident Stress Management training course in Huntington Beach in October, which focused on tools that peer support members can use to facilitate debriefings after critical incidents.

The *Downey Police Department Communications Center* received 135,890 telephone calls, 41,398 via the 9-1-1- emergency telephone system during the 2011 calendar year. Additionally, 83,342 calls for service were handled by the Police Department.

During August, Detective Kurtz and his partner, K-9 Duke, made significant narcotic seizures leading to several arrests. The team has also been involved with investigating narcotics shipped through private companies, and K-9 Duke has located considerable amounts of Cocaine, Methamphetamine, Marijuana and over \$35,000 in US currency concealed in packages bound for shipment throughout the United States.

In November, *Detective Kurtz and K-9 Duke* assisted the Los Angeles Interagency Metropolitan Police Apprehension Crime Task



In total, during 2011, K-9 Duke recovered over 165 pounds of cocaine, 93 pounds of marijuana, 46

pounds of methamphetamine, and over 1.3 million dollars in U.S. currency.

Downey Police *Narcotic Detectives* conducted an undercover operation in December that involved suspects in a large scale marijuana distribution case. Their investigation ultimately led to a single family residence in the City of Los Angeles where a search warrant was served. During the search, Detectives located approximately *300 pounds of marijuana* and \$100,000 in US Currency.

In October, a concerned citizen found a cell phone at a local gas station and discovered it contained child pornography. The phone was turned in to the Department, and the *Hi Tech Crime Unit* initiated an investigation. Through a detailed forensic examination of the phone, the Unit was able to identify the owner. The suspect, who was residing in Los Angeles with family members, including small children, was arrested and charged with possession of child pornography.

In May Detectives Ron Gee and Tim Lau provided two 30-minute presentations on *Internet Safety* to almost 2,000 students at Warren High School and 2,000 students at Downey High. The presentations educate students regarding the safe use of "Social Networking" sites such as "Facebook" and "MySpace," along with the possible consequences of "Cyberbullying" and "Sexting." In addition, the Unit has spoken at Neighborhood Watch meetings and has educated over 9,000 adults and children on internet safety.



In early December, Forensics Supervisor Ted Hiler was honored to be a guest speaker at a Schengen European Counselor meeting at the Consulate General of the Republic of Poland in Los Angeles. Ted, who was born in Ledziny Poland, has extensive background and experience in his field, and he spoke to the group of European Ambassadors on the topic of Forensics Science and DNA Computer Forensics, sharing many stories of his years in law enforcement.

During 2011, Forensics Supervisor Ted Hiler attended over 280 hours of computer forensics software training at the Guidance Software headquarters in Pasadena. In early 2012, Ted will be certified as a Computer Forensics Examiner with this software.








This handsome group was onboard to proudly escort Downey's award winning 2012 Rose Float entry back into the City

### Neighborhood Watch Program





Jane was a volunteer Police Explorer for four years and a Police Aide for six years before taking over this new position. She holds a Bachelor's Degree in Political Science and Criminal Justice from California State University in Fullerton.






## THE USUAL SUSPECTS



## MEMORIAL

On September 22nd, we proudly unveiled a Fallen Officer Memorial in honor of Officer Wayne R. Presley, the only Downey officer to be killed in the line of duty. This year marked the 30-year anniversary of the night Officer Presley was killed by a drunk driver and Sergeant Steve Guthrie was critically injured. The ceremony was attended by the entire Department, City leaders and Legislative representatives, City Hall co-workers, former employees, retirees, family who traveled from Missouri to attend, and Linda Ray, Officer Presley's widow. Our Honor Guard performed a moving flag-folding ceremony that included retired Sergeant Guthrie receiving the flag and placing it on the monument.




## TRIBUTETO JERRY GATON
