Temporary Paper Plates (AB 516): Authorized California dealers must place a paper plate with a number and expiration date on every vehicle they sell, whether new or used. The objective is to reduce the number of offenders passing through payment booths and improve road safety.

The new temporary paper plates will fall under the laws pertaining to license plates which have been amended to include temporary license plates.

Example:

Effective January 1, 2019, Section 5201 is added to the Vehicle Code, to read:

5201.

(a) License plates, **including temporary license plates**, shall at all times be securely fastened to the vehicle for which they are issued so as to prevent the plates from swinging, shall be mounted in a position so as to be clearly visible, and so that the characters are upright and display from left to right, and shall be maintained in a condition so as to be clearly legible. The rear license plate shall be mounted not less than 12 inches nor more than 60 inches from the ground, and the front license plate shall be mounted not more than 60 inches from the ground, except as follows:

Therefore, paper plates advertising dealerships/companies are no longer allowed to be issued by dealerships on new or used vehicles sold on or after January 1, 2019. Vehicles sold on or after this date **shall have temporary license plates issued.
