SUBJECT: RECEIVE AND FILE THE CITY OF DOWNEY AMERICANS WITH DISABILITIES ACT (ADA) TRANSITION PLAN ANNUAL REVIEW AND UPDATE

RECOMMENDATION

That the City Council receive and file the City of Downey ADA Transition Plan annual review and update.

BACKGROUND

The Americans with Disabilities Act (ADA) requires public agencies to perform a self-evaluation of infrastructure, programs and activities, and develop a plan for bringing infrastructure into compliance with the ADA. Over the last six years or so, the City of Downey began working on an ADA program which included a self-evaluation and development of a transition plan to bring City infrastructure into compliance with the ADA.

The self-evaluation process was conducted in Fiscal Year 2016-2017, by the City's consultant, Disability Access Consultants (DAC) which included inspections of City facilities and public rights-of-way. The inspection findings, including information regarding the type of ADA upgrades and repairs, locations, photographs of those areas, and the estimated dates the findings were scheduled to be repaired were subsequently developed into a transition plan.

As part of the development of the transition plan, the City reached out to residents and organizations serving the needs of persons with disabilities for input on how the City can best serve the needs of persons with disabilities. After self-evaluation and transition plan were completed, the transition plan was made available for public review. The City appointed an ADA Coordinator to address City-related ADA matters, created an ADA grievance policy and grievance form, dedicated a webpage on the City website for ADA matters and created various forms of communications for members of the public to contact the City regarding these items (dedicated telephone line, email address, etc.). The public may submit ADA complaints in person or through the web page as well as get information on the City transition plan, ADA grievance policy, and procedure.

On January 23, 2018, the City Council received and filed the City of Downey ADA transition plan. Because infrastructure improvements, including ADA upgrades and repairs occur continuously throughout the year in the adopted Capital Improvement Project (CIP) program, the City Council directed Public Works staff to perform an annual review and update of the transition plan to ensure that the plan remains relevant and realistic. For the past three years, the City Council received and filed the subsequent City of Downey ADA Transition Plan annual reviews and updates.

DISCUSSION

The City has completed numerous ADA repairs and upgrades to City facilities and public rights-of-way through the CIP program and other routine maintenance activities since the ADA transition plan has been completed. Staff has been utilizing the DAC software to assist in tracking ADA repairs and upgrades which has allowed staff to update the transition plan as needed.

For the period of October 1, 2020 through September 30, 2021, 18 ADA grievances and accommodation requests were received by the City's ADA Coordinator and Public Works Department. Of those requests, 5 were resolved by the ADA Coordinator, 9 were addressed by the Public Works Department, 3 were added to an upcoming CIP that will be completed within the next year, and 1 was noted as non-ADA related and forwarded to the responsible parties to respond.

Additionally, the City received 174 ADA grievances from a resident. Of the requests, 65 were not ADA violations as there were paths of travel at the stated locations, 4 were addressed by the ADA Coordinator, 5 were referred to and resolved by the Code Enforcement Division as the concerns were located on private properties, 4 were forwarded to utilities companies as they were the responsible agencies, 40 were resolved by the Public Works Department, and 56 were added to a future CIP project that is scheduled to be completed in the next year.

Furthermore, for the same period, the City has completed 555 sidewalk repairs and upgraded 103 curb access ramps with a total cost of approximately \$800,000. The following is a summary of the ADA repairs and upgrades completed:

Over the next three years, staff is anticipating implementing over \$6 million in ADA improvements and concrete sidewalk repairs as part of the Measure M and Measure R bond-funded street rehabilitation project at various locations in the City.

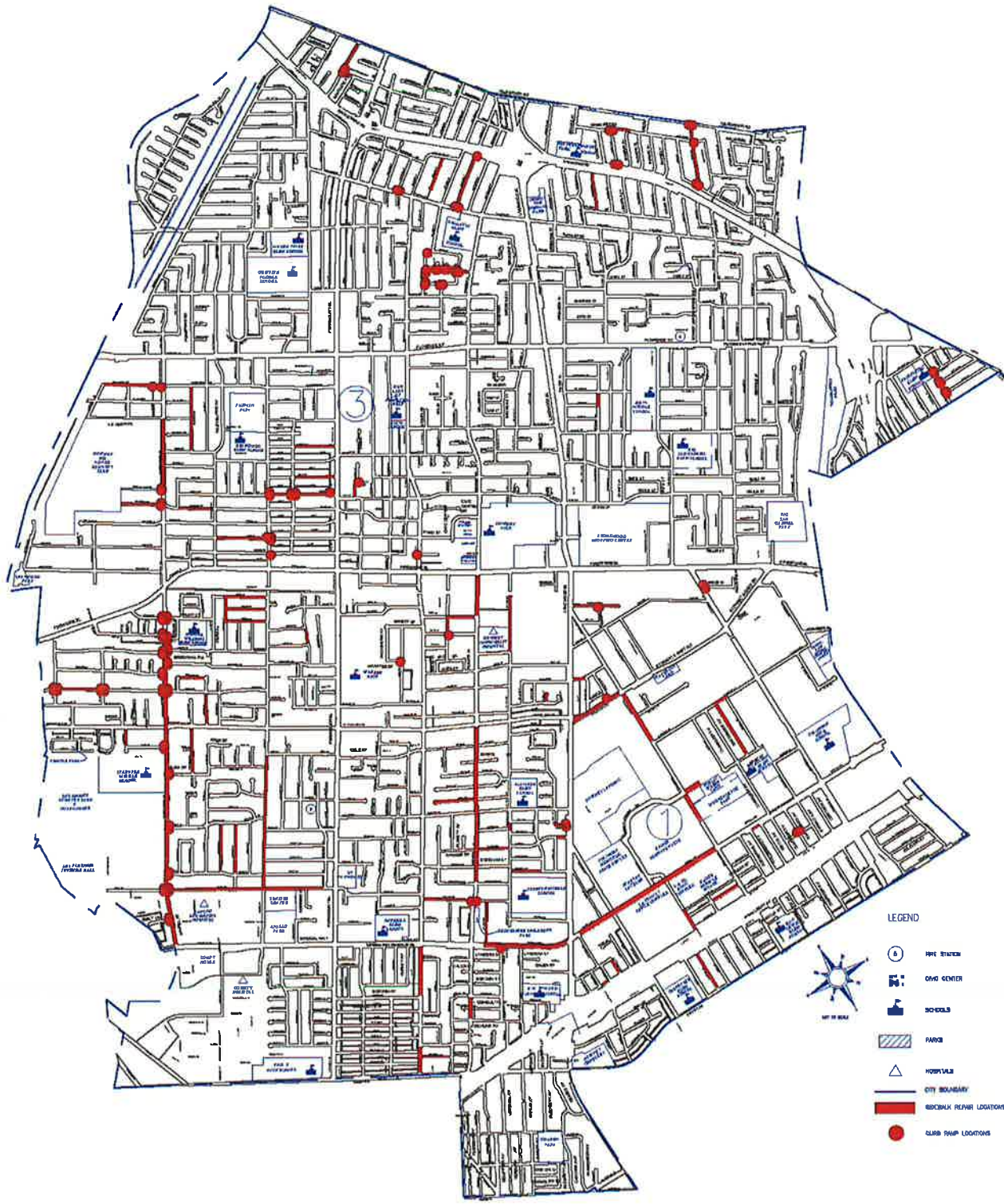
