

**RESOLUTION NO. 22-8062**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DOWNEY  
CONSENTING TO THE ASSIGNMENT OF INTEGRATED WASTE  
MANAGEMENT SERVICES FRANCHISE AGREEMENT BETWEEN THE CITY  
OF DOWNEY AND CALMET SERVICES, INC. TO ATHENS SERVICES**

**WHEREAS**, pursuant to Downey City Charter 1403, the City Council is required to adopt an ordinance to grant an exclusive Franchise Agreement for solid waste collection within the City;

**WHEREAS**, Calmet Servies, Inc. currently provides the City of Downey with solid waste, recycling and organic disposal services pursuant to the Franchise Agreement for Integrated Waste Management Services dated April 1, 2016; and,

**WHEREAS**, on December 9, 2021, Athens Services submitted a letter of request for Consent to Assignment of that certain Agreement for Integrated Waste Management Services to assign the Agreement to Athens Services; and,

**WHEREAS**, Athens Services will aquire assets of CalMet Servies, Inc. including its solid waste and recycling collection services; and,

**WHEREAS**, the Franchise Agreement between the City of Downey and CalMet Services, Inc. allows for assignment and delegation of the Agreement with the prior written consent of the City. Specifically, Section 27.1 of the Agreement states, "Calmet shall not convey, assign, sublet, license, hypothecate, encumber or otherwise transfer or dispose of (collectively "Transfer"), this Agreement, the franchise granted under it or any rights or duties under it, in whole or in part, and whether voluntarily or involuntarily, without the City's prior written consent as expressed by written resolution of the City Council"; and,


**WHEREAS**, any application for franchise transfer shall be made in a manner prescribed by the City Representative. The application shall include a Frachise Transfer Application Fee in the amount of \$150,000; and,

**WHEREAS**, the City Council of the City of Downey hereby provides this consent to assignment of the Franchise Agreement between the City of Downey and CalMet Services, Inc. for Integrated Waste Management Services to Athens Services.

RESOLVE AS FOLLOWS:**
