New Financial Crimes Forms

As a result of recommendations from the recent Detective Bureau Workflow Committee, the Department is introducing a new protocol that should help streamline the process and decrease the work load for responding report takers of some financial crimes that are not committed, but reported by resident victims in our jurisdiction. This new process will require responding personnel to utilize a new 530.5 / 484g PC report form for certain cases.

In order for an incident to qualify under this new process, the employee needs to confirm the crime took place at a physical location outside of Downey. In such cases, only an incident number is needed to complete the form. The new form was created by incorporating an editable PDF fill-in-the-blank document and a brief written description containing pertinent information about the fraudulent accounts.

This new form shall be used for the following crimes that occurred outside of Downey:

530.5 PC - Identity Theft

484g PC - Fraudulent use of a credit/debit card

- Examples include:
 - Unauthorized use of an EBT/Debit/Credit cards that occurred out of the city.
 - The use of the victim's personal information to obtain credit, bank accounts, or other services at an identifiable location out of the city.

As a reminder, any misuse of debit card or identity theft report should include a printed document, such as an account statement, which indicates the account number, date, amount and location of any fraudulent transactions.

Once the form has been completed and approved by a supervisor, the officer shall take the form to records where it will be added to the incident and forwarded to the responsible agency.

All other financial crimes that do not meet these requirements should be taken as a normal crime report with an associated DR.
