- Participate in youth Commission weekend or school events
- The Chair or Vice-Chair of the Commission or his/her representative shall attend the Downey City Council meetings once a month
- Time commitment is two to six hours per month. Commission meetings are held the third Thursday of each month at 4:00 p.m. The first meeting is scheduled to be in September.

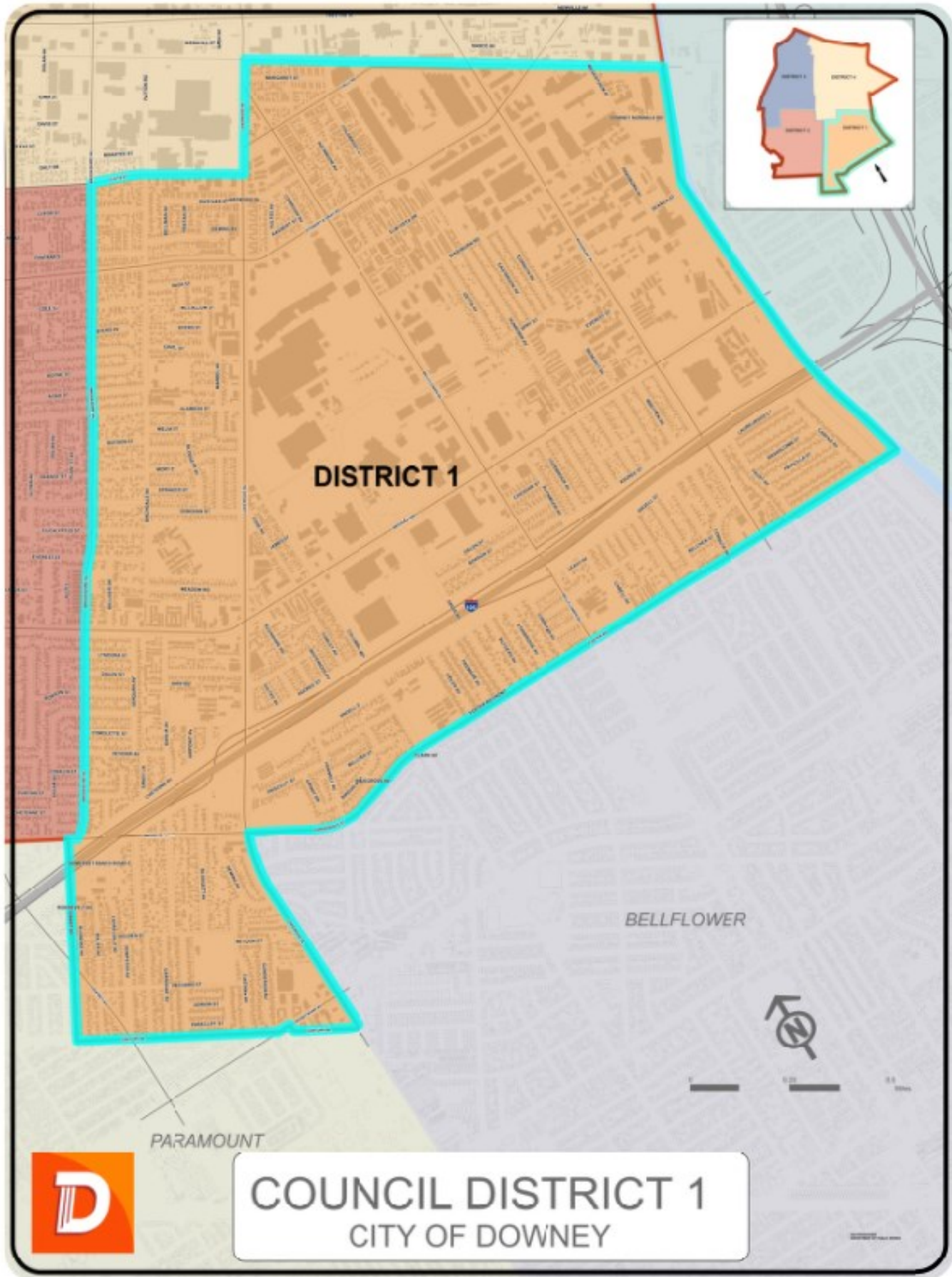
